# CDC for Migrants in Border Areas

- Early detecting
- Timely reporting
- Immediately Respond
- Information change



# **Some problems for CDC in cross-border areas**

- a. Insufficient information communication, which results in poor understanding of the status of CDC on both sides**
- b. No joint action for outbreak in cross border areas**
- c. No sharing of health resources between two sides**
- d. No enough funds to support**



# Future Cooperation Plan for CDC in Cross-border Areas

## **1 objectives**

- 1.1 To establishing long-term and effective system for epidemic information communication in cross-border areas
- 1.2 To establishing joint action mechanism dealing with important epidemic in cross-border areas
- 1.3 To increase the experience communication between two counties, enhance training to improve the ability of disease prevention and control, and reduce the incidence and mortality of priority diseases



# Future Cooperation Plan for CDC in Cross-border Areas

## 2. Activities

### 2.1 Establishing long-acting mechanism for information communication in the cross-border areas

- a. Basing on the principles of equality, a fixed contact agency and person should be set up, and the network for information exchange in the cross-border area should be perfected. Besides, the contact pamphlets and working guideline should be made in both language.
- b. Basing on related rules on epidemic reporting of each country, the content way and information should be confirmed.
- c. The responsibility of related agencies at different level and related personnel in information communication should be defined.



# Future Cooperation Plan for CDC in Cross-border Areas

## d. Regular communication

- The epidemic information and disease control information should be exchange monthly in the cross-border areas (through Email, internet, fax, telephone,etc.)

## e. Important Epidemic Information Report

- When important epidemic incident occurs, it should be reported to the other side as soon as possible (no more than 24 hours)



# Future Cooperation Plan for CDC in Cross-border Areas

## f. Routine Conference

- Routine conference should be held seasonally in the cross-border areas to analyzing the epidemic status of that season. The experience of cooperation should summarized, details of cooperation should also be defined to promote understanding and cooperation of two countries

## g. Irregular information exchange

- According to the temporary need of disease control, irregular information exchange should be conducted so as to communicate with others in time



# Future Cooperation Plan for CDC in Cross-border Areas

- 2.2 Establishing experts group on both sides
- 2.3 Sharing disease surveillance system and laboratory
- 2.4 Drug storage system in case of emergency
- 2.5 Providing special funds for outbreak



# Future Cooperation Plan for CDC in Cross-border Areas

## 2.6 Taking joint action

When important epidemic occur, the information should be reported to the other as soon as possible

When outbreak involve both sides, the treatment can be made jointly

When important epidemic occurs on one side or both sides, the quarantine station should be set up on the border port by two sides

2.7 Establishing joint investigation team

2.8 Fully using each own advantages, two countries exchange staff to have long-term or short-term trainings

2.9 Two countries exchange experts to give technical guide and give training lectures
